Rules and Regulations

1. **RULES: Fees will be \$25 per booth.** All booths needing electricity will pay an additional \$5 fee per booth.
2. Booth fees are non-refundable. Booth size is 12'x12'; limit of two booths per applicant. **Pop-up canopies only; absolutely no stakes may be driven in the grounds of the courthouse**
3. Exhibitors must provide their own tables and chairs and be responsible for their own set-up and removal.
4. Set-up time is 8 a.m. to 9:45 a.m. on the days of the festival. (Sun. 10:00 to 4:00) **There will designated vendor parking west of the courthouse and marked areas on the north side.**
5. Food vendors must comply with Texas Department of Health guidelines for temporary food establishments.
6. Booths will be manned at all times and we request that you to stay until the end.
7. Booth spaces will be assigned ahead of time. Participants will receive a confirmation letter with booth space assignment, map, and other information.
8. Neither the City of Llano, Llano Main Street Program, nor Llano Chamber of Commerce will be liable for loss or damage of property from any cause, nor will they be responsible for accidents on the grounds, adjacent roads, or highways.
9. This is a juried show and places will be designated on the north or south sides of the Llano River, headquarters at the Llano Rail Yard Depot.
